- ### 2. Essential requirements for admission
- Entry into AIM's Bachelor of Music programs is based upon achievement of a satisfactory level of secondary or higher education, audition/interview, submission of portfolio covering all relevant musical/entertainment experience and proficiency in the English language.

**Entry into the Bachelor of Music** at AIM requires an **audition** and **interview** to assess skills and aptitude to study. The audition process allows AIM to assess potential and advise on the best course of study.

#### 4. Admission criteria

##### A. Applicants with higher education study

To be eligible for admission into the Bachelor of Music programs on the basis of tertiary (HE) studies, you need to have completed at least 6 months of full-time study (or the part-time equivalent) at AQF Bachelor's degree level or higher. If you have not completed 6 months, you will be assessed on your secondary results (refer D below). Please note that other selection criteria, including English proficiency and audition will be taken into account (for more information see the *Admissions Policy (incorporating English Language Proficiency Requirements)*).

##### B. Applicants with vocational education and training (VET) study

To be eligible for admission into the Bachelor of Music programs on the basis of Vocational Education & Training (VET) study, you must have successfully completed an AQF VET qualification (Certificate 4 and above). If you have not completed a VET qualification at Certificate 4 or above, you will be assessed on your secondary results (refer D below). Please note that other selection criteria, including English proficiency and audition will be taken into account (for more information see the *Admissions Policy (incorporating English Language Proficiency Requirements)*).

##### C. Applicants with work and life experience

Applicants who are over the age of 21 will be assessed as mature-age entry (for more information see the *Admissions Policy (incorporating English Language Proficiency Requirements)*). Applicants who are under 21 but have completed their Australian Senior Secondary Year 12 Certificate (or equivalent) will be assessed on the basis of their Year 12 Certificate, their satisfactory performance audition and assessment by the Deputy Director of Academic Affairs of their overall ability to undertake the program of study and to achieve the course outcomes.

For applicants who do not meet the above criteria, admission may be granted by the Deputy Director of Academic Affairs or nominee based on a documented assessment of the applicant's overall ability to undertake the program of study and to achieve the course learning outcomes.

##### D. Applicants with recent secondary education (within the past two years)

To be eligible for admission into the Bachelor of Music programs on the basis of recent secondary education applicants must have:

- completed an Australian Senior Secondary Year 12 Certificate (or its overseas equivalent as assessed by the Department of Education and Training (DET)) in the past 2 years.
- completed the International Baccalaureate (IB) Diploma qualification in the past 2 years

Applicants who completed their senior Secondary Year 12 Certificate (or equivalent) more than 2 years ago will be assessed on the basis of Work and Life Experience (refer C above).

##### Victorian Year 12

Applicants must have completed an Australian Senior Secondary Year 12 Certificate in the last 2 years; for VCE (Victorian Certificate of Education) Students; Satisfactory completion of the VCE and Units 3 and 4 English. Any of the four VCE English studies - English, English as an Additional Language, Literature or English Language - satisfies the requirement for English; however, Units 3 and 4 must be completed in sequence and in the same calendar year.

VCAL (Victorian Certificate of Applied Learning): The completion of Senior VCAL will be recognised for entry in the Diploma of Music providing you meet all other entry requirements.

### 5. How to apply

Application for Admission should be made on the AIM Admission Application Form and submitted to the Enrolment Team by email [recruit@aim.edu.au](mailto:recruit@aim.edu.au) together with all supporting documents (certified copies) including:

- academic documents – certificates, transcripts
- birth certificate or passport (ID page)
- English proficiency documents (international students)
- Portfolio

The Enrolment Team is available to answer any questions and process your application for assessment by the Enrolment team and will contact you to arrange an Audition/Interview. For further information on the interview process click [here](#).

If all the documents and information are complete and satisfactory, and you have successfully completed your interview, you can expect to receive a *Letter of Offer* and *Course Enrolment Form* within 5 working days thereafter. The *Letter of Offer* will provide all details of your proposed course enrolment and information on next steps to be taken to finalise your enrolment.

Once you receive and review your *Letter of Offer* and wish to proceed please return the *Acceptance of Offer* form and *Course Enrolment Form* to the Enrolment Team together with any outstanding documents or information specified in the Letter of Offer and details of deposit paid (if required).

If you are seeking recognition of prior learning, you should also lodge an *Application for Recognition of Prior Learning* together with required supporting documents.

AIM will then provide you with a Letter of Confirmation and additional information to assist with your studies. If you are eligible and wish to fully or partly utilise FEE-HELP to pay for your tuition fees you must complete the electronic Commonwealth Assistance Form (eCAF) online via the link which will be sent to you via email upon receipt of your signed *Acceptance of Offer* and *Enrolment Form*

### 6. Advanced standing/academic credit/recognition of prior learning (RPL)

You may be entitled to credit for prior learning, whether formal or informal. Formal learning can include previous study in higher education, vocational education, or adult and community education. Informal learning can include on the job learning or various kinds of work and life experience. Credit can reduce the amount of study needed to complete a degree.
